Agreement and Release of Liability

I recognize that Cincinnati Area Ducati Riders & Enthusiasts, Inc. is separate from Ducati Motor Holding SpA and Ducati North America Inc. and remains a separate entity solely responsible for its actions.

I, (the undersigned), wish to participate in the Cincinnati Area Ducati Riders & Enthusiasts, Inc. organized rides and events. In return for my being permitted to do so, I voluntarily give this Release of Liability. I also agree to comply with the Cincinnati Area Ducati Riders & Enthusiasts, Inc. rules and regulations and abide by all rules verbally set forth by the Cincinnati Area Ducati Riders & Enthusiasts, Inc. representatives.

I am aware that motorcycling can be dangerous. I could be injured, killed, have property damaged or be held responsible for harm to others. I am voluntarily participating in the Cincinnati Area Ducati Riders & Enthusiasts, Inc. rides and events with knowledge of the dangers, and I accept all of the risks. I am about to engage in motorcycling, an activity that is dangerous and could pose risks to my person and property. I acknowledge that I do so freely and voluntarily, on a personal basis, and that no promises have been made to me regarding my safety or the extent of the risk involved.

I also hereby RELEASE, WAIVE, DISCHARGE AND PROMISE NOT TO SUE the entities and persons listed below from any and all liability to me – in damages or otherwise – in conjunction with my participation in the Cincinnati Area Ducati Riders & Enthusiasts, Inc. rides and events. This includes for any injury, death or property loss to me, and for any injury, death or property loss to others claimed to be my responsibility. This also includes for any indemnification, contribution, subrogation or exoneration that may be sought by me or through me. To the fullest extent permitted by law, this also includes if any such injury, death, loss of responsibility is cause or contributed to by the negligence or other wrongful conduct of any of the below-listed persons or entities.

I further agree to DEFEND, INDEMNIFY AND HOLD the below listed persons and entities HARMLESS from and against all claims, demands, losses and expenses, including attorney fees, asserted or incurred by reason of such injury, death, loss or responsibility. This again includes if caused or contributed to by the negligence or other wrongful conduct of any such persons or entities.

These persons and entities include: Ducati Motor Holding SpA, Ducati North America Inc., Cincinnati Area Ducati Riders & Enthusiasts, Inc., Ducati dealers organizing or assisting with the ride or event, all organizations affiliated with them, all sponsors or contributors to the ride or event, all governmental agencies involved or assisting with the ride or event, all employees, officers, agents or volunteers of all the forgoing, and all other persons and entities otherwise involved in organizing, operating or assisting with the ride or event.

I give this Release and other things in connection with my entire participation in the ride or event, whether as a driver, passenger or any other capacity. I also give this Release and other things on behalf of, and I agree that they will be binding upon, my heirs, representatives, assigns, dependents and anyone else who might claim a loss on account of anything happening to me.

I further agree to waive all benefits flowing from any state statute, which would negate or limit the scope of this Release and Indemnification Agreement.
